

## National Recognition – Updates and Who Is Recognized (cont'd)

USPS also recognizes certain U.S. Coast Guard licenses (which are currently in effect), USCG Auxiliary courses, and Canadian Power & Sail Squadron courses as equivalent to USPS courses. The SEO can assist a member who desires to get credit for an equivalent course.

**EDUCATIONAL PROFICIENCY** is awarded to anyone attaining a grade level of at least Advanced Pilot (AP) and completing at least three Elective Courses. The Grade behind the member's name is underscored to indicate this level of advancement. **Our members who have been so recognized are:**

**EDUCATIONAL ACHIEVEMENT** is the highest educational recognition award given by USPS. **A person with this award is known as a Senior Navigator** and uses the printed grade designation of SN. The SN grade is awarded to anyone attaining the N, JN, OM, CM, or IM grade plus a specified number of electives and additional advanced courses. There are now 5 paths to Senior Navigator:

1. N grade + 6 of: CUPS, EM, ID, MCS, MES, Radar, Sail, WE, IB	CUPS - Cruising Under Power and Sail, which includes its precursors: (1) Cruise Planning and (2) Cruising and Cruise Planning
2. JN grade + 7 of: CUPS, EM, ID, MCS, MES, Radar, Sail, WE, IB	CN - Celestial Navigation
3. OM grade + 7 of: CUPS, EM, ID, MCS, MES, Radar, Sail, WE, CN, IB	EM - Engine Maintenance
4. CM grade + 7 of: CUPS, EM, ID, MCS, MES, Radar, Sail, WE, IB, ON	IB - Inland Boating (under development)
5. IM grade + 7 of: CUPS, EM, ID, MCS, MES, Radar, Sail, WE, CN, ON	ID - Instructor Development (which for this purpose includes IQ-Instructor Qualification)

	MES - Marine Electrical Systems
	ON - Offshore Navigation


## Reporting navigation hazards – It depends

There are plenty of agencies that have jurisdiction on the **Tennessee River System**, so who do you call when there is something out of place or otherwise hazarding navigation.

**COAST GUARD?** USCG is responsible for safe navigation within the **primary channels** of the Tennessee River System. These are the channels navigable by commercial vessels (e.g., ships, tugs and barges).

- **OUACHITA:** The most noticeable Coast Guard (USCG) presence on the water is the OUACHITA, which is a 65-foot river buoy tender, that maintains aids to navigation (ATON), which comprise of floating buoys and fixed beacons. If there is a discrepancy with the ATON, meaning that they are not properly standing watch (e.g., out of position), USCGC OUACHITA will address the matter. But it is not the point of contact for receiving a report.
- **NAVIGATION CENTER:** ATON discrepancies are reported to the USCG Navigation Center. The Navigation Center is responsible for issuing safety notices and advising USCG Sector Ohio Valley, which oversees OUACHITA, that action is required. The online “**ATON Discrepancy Report Form**” is accessible at: <https://www.navcen.uscg.gov/contact/aton-discrepancy-report>. Simply fill out all fields that seem applicable; for example, Tennessee River ATON won’t be found in Light Lists and are not lighted.
- **SECTOR OHIO VALLEY:** For other navigational hazards that could obstruct the primary navigation channel, contact USCG Sector Ohio Valley. It will likely issue a Local Notice to Mariners. When underway, contact “Coast Guard” using Channel 16. You could also call the Command Center at **502-779-5422**.

**TENNESSEE VALLEY AUTHORITY?** TVA has jurisdiction over the **secondary channels** of the Tennessee River



System. These are channels that serve recreational boaters. Discrepancies with buoys, daymarks and other aids are reported through the “**Navigation Aid Problem Report Form**,” which is accessible at: <https://tvafoms.wufoo.com/forms/sffnd061jwnb8b/>.

In September John Farmer reported an obstruction under a downtown Knoxville railroad bridge to TVA using [TVAINFO@TVA.GOV](mailto:TVAINFO@TVA.GOV). He included a screenshot of the channel in his report. He used OpenCPN and electronic charts provided by the Corps of Engineers (see below). Thanks, John, for looking out for fellow boaters, even the Vol Navy.

## Membership program streamlines new member enrollment

USPS initiated a “Direct-to-Squadron” Membership Program that streamlines how new members can join. Our bridge agreed to comply with the program. In doing so, our squadron had to modify its by-laws and accept two conditions required by USPS. These were:

1. **Our by-laws were amended to permit the enrollment of new members without requiring Executive Committee approval.** This approval process had not been used for several years; so, it was a moot issue.
2. Our squadron had to waive its right to approve new members coming from National prior to enrollment in our squadron. We have had members enroll online, which made them part of the USPS cyber squadron. Then they transferred to us. The earlier mentioned approval process was not used; so, it again was a moot issue.
3. Lastly, our squadron waived its ability to charge initiation fees to new members who are added from National. Our squadron hasn't charged this fee; so, it again was a moot issue.



## Educational Department Technical Corner by John Farmer

A new USPS seminar on NMEA 0183 and NMEA 2000 is tentatively planned for release on/after September 2026.

The older NMEA 0183 ( <https://www.nmea.org/nmea-0183.html> ) uses the 4-wire RS-422 protocol, and you may have to swap wires and try different baud rates until it works. Unless it is the high-speed version, it typically runs at 4,800 baud. Connecting a VHF radio and a depth sounder. 0183 uses a single sender and can have multiple listeners. My Float Hub vessel monitor has one 4800 baud port and one highspeed port for AIS signals from my VHF-AIS receiver.



NMEA2000 uses a proprietary physical connector, baud rate, and cable, making it easier to connect ( <https://www.nmea.org/nmea-2000.html> ). Unfortunately, at least one manufacturer uses their variant and does not follow the standard.

The new NMEA One Net standard ( <https://www.nmea.org/nmea-onenet.html> ) is complete and uses a faster Ethernet protocol to handle radar signals and other high-speed data. I had to use a separate Ethernet cable on THE STAR riverboat to connect my digital, spread-spectrum radar to my Simrad multifunction display. The new standard uses Ethernet everywhere, and gateway devices will be coming to connect existing NMEW2000 or 0183 devices to the new network.



So, take the USPS NMEA seminar after September 2026 to get up to speed on existing technology and get ready for the future of marine electronics connectivity.
